As the first wholly foreign-owned financing guarantee firm in Shaanxi Province, the agreements will provide an immediate business platform and installed customer base for Chinlink Finance to operate in, thereby crystalizing the Group’s long term vision in becoming an integrated finance and logistics services provider in China.
